
- k. Founder Trustee shall be the Managing Trustee and Chairman of the Trust for the time being and founder trustee shall be fully in charge of administration and day to day affairs of the trust.

10. Bank account shall be opened in the name of the Trust in any of the Scheduled Banks through a proper resolution to be presented to the Bankers for the opening of such bank accounts and the Managing Trustee shall operate such bank accounts.
